#### I. CALL TO ORDER

A regular meeting of the Board of Park Commissioners of the Washington Township Park District, also known as the Centerville-Washington Park District, was held at Park Headquarters. The meeting was called to order at 7:32 P.M. with the following attending: Commissioners Lee, Monahan and Sánchez; Mr. Biondo, Director; Mr. Carter, Operations Manager; Mr. Meyer, Project Manager; Ms. Marks, Program Manager and Ms. Huff, Business Manager. # II. CHANGES OR ADDITIONS TO THE AGENDA

No changes or additions were made.

#### III. APPROVAL OF MINUTES

Commissioner Lee moved, and Commissioner Monahan seconded for approval of the work session and regular meeting minutes from March 11, 2019. Commissioners Lee, Monahan, and Sanchez: all ayes, motion carried.

#### V. FISCAL

## A. Approval of Financial Activity

Commissioner Lee moved, Commissioner Sanchez seconded, to authorize the March 2019 financial and investment activities. Commissioners Lee and Sanchez: ayes, motion carried.

## VI. BUSINESS

## A. Amended Purchase Agreement

The Township Trustees approved the amended agreement on March 18. Closing is targeted for April 23. The amended agreement allows for the State-directed sequence of the Park District owning the building before getting notice to proceed. None of the costs or other terms are changed. A Resolution was passed authorizing Director Biondo to sign documents relating to said purchase.

Commissioner Monahan moved, Commissioner Lee seconded, to approve Resolution 2019-11, authorizing Director Biondo to sign purchase-related documents for the property currently referred to as Hithergreen (5900 Hithergreen Drive) and further authorized President Sanchez to be signatory on the Resolution. Commissioners Lee, Monahan and Sanchez: all ayes, motion carried.



## B. Notice of Bid to Demolish Hithergreen School Building

Following the new terms of the Hithergreen purchase, the District will now contract for the demolition of the old school building. This Board action acknowledges and authorizes the process to take competitive bids for that work.

Commissioner Lee moved, Commissioner Monahan seconded, to authorize the process of accepting competitive bids for the demolition of the Hithergreen building and pavement, in accordance with the terms of the purchase

and the Clean Ohio Grant. Commissioners Lee, Monahan and Sanchez: all ayes, motion carried.

## C. Acceptance of the Yeck Master Plan

Park Board formal adoption of the Master Plan will provide assurance to future staff, commissioners and granting agencies that the plan has been studied and approved by the Board.

Commissioner Sanchez moved, Commissioner Lee Seconded to adopt the Bill Yeck Park Master Plan. Commissioners Lee, Monahan and Sanchez: all ayes, motion carried.

# D. Resolution to apply for Clean Ohio Green Space Conservation Grant- Yeck Park

Staff sees an opportunity to win grant funding for much of the work outlined in the new Master Plan. The grant funds could be as much as 75% of a project cost.

Commissioner Lee moved, Commissioner Sanchez seconded, to approve Resolution 2019-10; and further authorized President Sanchez to be signatory on the Resolution. Commissioners Lee, Monahan and Sanchez: all ayes, motion carried.
