VI. BUSINESS

A. Schoolhouse Park Hardscape Improvements

Three bids were received for the Schoolhouse Park Hardscape Improvements, which includes removal of the existing painted/stamped asphalt and replace with concrete between the basketball and tennis courts, as well as remove and replace cracked concrete in and around baseball dugouts. A total of \$40,000 was budgeted for this project in 2025. The lowest, best bid is Sowder Concrete Staff recommends awarding this project to Sowder Concreate in the amount of \$40,000.
